Cara memohon / How to apply

1. Borang STM1 hendaklah dilengkapkan dengan sempurna untuk semua permohonan STM/
Form STM1 duly completed for all COR application
2. Gunakan Borang STM1A bagi memohon lebih daripada 1 sijil / *Use Form STM1A if application is for more than 1 certificate.*
3. Dokumen yang perlu disertakan/ *Documents need to be attached*

i. Syarikat / Company

- a. Jika borang nyata masih belum patut dikemukakan, sertakan salinan Minit Mesyuarat Lembaga Pengarah **atau** surat pengesahan pengarah berkenaan pengurusan dan kawalan syarikat dilakukan di Malaysia/ *If the return form is not due yet, a copy of the Minutes of Board of Directors' Meeting, or a letter signed by a director confirming the management and control of the company are exercised in Malaysia;*
- b. Borang 49 dari Suruhanjaya Syarikat Malaysia (SSM) / *Form 49 from Companies Commission of Malaysia (CCM)*

ii. Individu / Individual

- a. Pasport asal dan salinan / *Original passport and photocopy*
- b. Senarai pergerakan keluar / masuk Malaysia / *List of movement in / out of Malaysia*

iii. Perkongsian / Partnership

- a. Pasport asal ahli kongsi individu serta salinannya / *Original passport (and photocopy) of the partner applying;*
- b. Senarai pergerakan ahli kongsi individu keluar/masuk Malaysia / *List of movement of the individual partner in/out of Malaysia.*

iv. Badan Amanah / Trust

Salinan suratikatan penubuhan Badan Amanah (bagi fail baru daftar) / *A copy of the trust deed (for newly registered file)*
